By becoming a member of the Three Rivers Community Choir you acknowledge that you have read and agreed to the following terms and conditions:

Health and Safety

In respect of members under the age of 18, the choir only accepts responsibility for these Junior members for the duration of the rehearsals. At all other times, responsibility lies with the parents/carers.

The choir aims to create a safe and positive environment for all its members. In order to do this, it must ensure acceptable standards of behavior from our members.

All members should be punctual to rehearsals.

All members should respond to the leadership of the Musical Director and be co-operative with all fellow members. You should help the choir to develop and uphold an equal opportunity environment. Any form of negative behavior, whether written, verbal or physical, towards others including choir members, leader or to the rehearsal venue will lead to cancellation of membership. No refund of fees paid will be given under these circumstances.

Members must understand that Three Rivers Community Choir cannot be held financially responsible for any damage caused by misconduct.

Members are responsible for their own property and well-being whilst attending rehearsals and performances.

All members must provide an emergency contact number should the need arise for the management committee to make contact should an issue occur during a rehearsal or performance.

Photographs

By becoming a member you agree that photographs and film footage may be taken of all the members and used for advertising and marketing purposes only in relation to the Three Rivers Community Choir. Footage, photographs and recordings can be put onto Social Media e.g the Choirs Facebook page without prior permission of the members. The choir's management committee reserve the right to remove unsuitable comments from Social media under their control.

Data Protection Act.

Personal and private information held by the choir management committee for the purpose of communication such as email addresses and home telephone numbers and mobile phone numbers will not be passed to external bodies, organisations, third parties or other members.

Music.

All music copies distributed for use by the members belongs to the choir and should be returned to the management committee should you leave the membership.

Payment for Choir Rehearsals

Payment for rehearsals is termly in advance by cash, cheque or BACS. There are no carry-overs or refunds for non-attendance. Should rehearsals not take place due to adverse weather conditions or illness of the choir leader then either a replacement leader will be sought or replacement rehearsal organised for an alternative time.
